## **Module description**

This module sets out to explore the notion of postmodernity across a range of literatures and language cultures from among the former communist states of East and Central Europe. The principal zones of exploration will be the former USSR (Russia and Ukraine); Poland; the Czech and Slovak Republics/former Czechoslovakia; Bosnia, Croatia and Serbia/former Yugoslavia; Bulgaria and other Balkan literatures. Most texts studied on the module are works published after the pivotal date of 1989 (1991 in the case of the former USSR), and thus the end of Communism. All texts are read and studied in English translation.

#### Assessment

The module is assessed through a 3,500-5,000-word essay.
