CL/04-05/004 Matters Arising from the Minutes A number of matters arising from the Minutes were

23rd June 2004) In response to a question concerning the revised points for A Level grades that will be introduced with effect from 2005, the Senior Lecturer stated that it was anticipated that the number of instances where the notice period caused difficulty would be few and such cases would be considered sympathetically on an individual

basis.

CL/04-05/006 Provost's Report

(i) Organisation for Economic Co-operation and Development (OECD) Report The Provost advised that the OECD Report on the review of higher education in Ireland had been published in mid-September. The report was wide-ranging and posed challenges for higher education institutions in terms of the management and governance of institutions, widening participation, lifelong learning, research and innovation, and the international dimension. The report also raised issues in relation to funding and investment. While it acknowledged the need for further investment in third-level education, it indicated that this should not come from the state and proposed that consideration be given to the re-introduction of undergraduate fees. It was agreed that the Conclusions and Recommendations sections of the report would be circulated for discussion at the next meeting.

(ii) European University Association (see Actum 52/C of 23rd June 2004) The EUA Review Team will conduct its main site visit to Trinity on 14-16th October 2004 and will give an oral presentation of its main findings on Saturday 16th October 2004. All Council and Board members, together with all those who would meet with the Review Team during its visit, had been invited to attend the presentation. It was noted that, in addition to producing a sectoral report, the EUA will prepare individual reports on each university.

CL/04-05/007

Research - Report from the Dean A report from the Dean of Research dated April 2004 had been circulated for the previous meeting and the Dean of Research attended for this item. The Dean of Research highlighted key points in the report as follows:

- (i) Trinity is the leading research university in Ireland and outperforms its competitor universities by any metric
- (ii) Research expenditure doubled between 1995-96 and 2000-01 and doubled again by 2002-03 to €47m.
- (iii) Research support systems are becoming increasingly important and the system being developed in College will provide a major resource of information on research in College
- (iv) The number of patents filed by the College has increased significantly in recent years
- (v) A five-year entrepreneurship plan will be completed during 2004-05
- (vi) Science Foundation Ireland (SFI) is becoming increasingly important and is a major funder of research in Irish universities.

The Dean of Research informed Council that SFI had requested that Colleges submit detailed Annual Overhead Investment Plans in respect of overhead funding, and that this was currently in preparation in College. Council noted that the OECD report had recommended that responsibilities and programmes of the Irish Councils for the Humanities and Social Science and for Science, Engineering and Technology be subsumed under an expanded SFI.

The Dean of Research stated that the Shanghai Jiao Tong University rankings, which focus mainly on science-based subjects but include a social science index, place Trinity at 104th in Europe and 269th in the world. It was noted that this was the first international ranking that included Ireland, and that such rankings are likely to become increasingly sophisticated. The Dean stressed the importance of benchmarking research against other institutions and indicated that the Research Committee would consider this matter further in the coming year.

In response to a question, the Dean of Research stated that he was proposing that the administrative staff complement in the Research Office be increased by two and that an appointment be made in the area of Intellectual Property. In addition, an appointment would be made in the Research Accounts Office and in the Staff Office. These appointments would be funded from research overheads and would allow the College to put in place appropriate service levels for SFI principal investigators and provide

support for funding applications to the Programme for Research in Third-Level Institutions (PRTLI) Cycle 4.

The Dean of Research answered a number of questions and clarified points raised and the Provost thanked him for attending the meeting and presenting the report.

CL/04-05/008

Key Principles/Issues associated with an Academically-based Resource Allocation Model A memorandum from the Provost dated 11th October 2004 had been circulated together with a paper from the Bursar dated 7th October 2004. The Provost had appointed a task force to prepare draft proposals for discussion in relation to the introduction of an academically-based resource allocation model. The membership of the task force was as follows: the Bursar (chair), the Senior Lecturer and the Dean of Research, supported by the Treasurer and the Academic Secretary.

The Bursar and the Dean of Research were in attendance at the Council meeting for discussion of this item.

The Bursar advised Council that the task force had begun to meet in early September and the circulated paper represented its draft proposals which would be finalised for consideration by Board at its meeting in December.

The draft proposals indicated that there were four distinct steps to full implementation of an academically based resource allocation model as applied to the core state grant, the first two being

- (i) Determine key academic criteria that shape the outcome of the model
- (ii) Determine the various ways in which achievement in meeting these criteria is to be measured.

The circulated paper addressed the first of these issues and to a lesser extent the second. In relation to item 1, there were three key weightings involved

- a. Top level weightings for the division of funding between teaching, research, and strategic/special factors
- b. Subject weightings to account for the different costs of educating a student in different subject areas
- c. Student type weightings which would be applied to the different types of student e.g. undergraduate, postgraduate taught, postgraduate research.

It was proposed that an amount of 5% be reserved from the core grant for strategic and special purposes. Thirty percent of the remaining allocation would be allocated to support research, and 70% for teaching. With regard to the teaching allocation, the Bursar noted that the subject weightings used by the Higher Education Funding Council for England (HEFCE) had been developed over many years following regular discussion with a large number of universities. The task force was of the view that the HEFCE subject weightings should be used in the new model and that deviations from these weightings should be minimal. In addition to subject weightings, student type weightings would be applied and proposed weightings had been included in the circulated paper. It was also proposed that the funding allocation for research from the core budget would be distributed on the basis of two indicators of research quality: (i) the number of research graduate students per eligible staff full-time equivalent (FTE), and (ii) the research expenditure per staff FTE.

The Bursar advised Council that the task force had yet to discuss in detail the bases on which indirect costs will be applied to an academic unit, and whether the data available to support application of these criteria were sufficiently robust. It was noted that until reliable data were available, it may be more appropriate to release only broad indicative information. Another issue to be considered by the task force was whether current

information systems in College were sufficiently comprehensive and integrated to facilitate implementation of the model.

Several members of Council welcomed the proposals and congratulated the Bursar and the task force on their work to date. In the discussion it was suggested that the task force might consider extending the number of subject weightings beyond the four stated in the HEFCE model. In relation to funding for clinical years in health sciences which attracted a HEFCE weighting of 4, it was suggested that the situation in the United Kingdom was very different to that in Ireland and therefore a direct correlation would not be appropriate. The Bursar commented that the task force had given careful consideration to this matter. However, he noted the discussion and indicated that the task force would consider the matter further.

A number of comments were made regarding the student type weightings. It was suggested that students from non-traditional backgrounds required additional support and this should be recognised as part of the model. It was acknowledged that part-time diploma students represented an important element of the College's lifelong learning activities, and that while part-time postgraduate diploma students make little demand on university facilities, they can make significant demands on staff running the courses.

In relation to the proposed indicators of research quality, it was possible in certain areas of the humanities and social sciences that excellent research could be carried out without a significant level of research funding. The Bursar indicated that variation in funding levels is being taken into account in the development of the model. It was suggested that the indicators could be limited by factors outside of the control of researchers, such as the need for additional accommodation to support the recruitment of additional research students. Another issue was that any significant increase in the number of research students could have an impact on the quality of supervision. The Bursar acknowledged that the allocation of funding to support research could be complex. However, the task force was of the view that the two indicators proposed represented a reasonable starting position in terms of recognising quality in research. It was also noted that the Research Committee would shortly consider proposals concerning the introduction of a benchmarking system for research in College.

A key principle of the model was that resources should follow activity. While much of the discussion had focussed on costs, it was also necessary to consider resource allocation in the context of incentives and the values that the College places on different activities.

The Senior Tutor commented that funding for Student Services should be such that support for students should not change depending on their Faculty location. It was noted that the task force had yet to consider in detail issues concerning allocation of indirect costs to academic units and how budgets for support areas are decided.

The Provost thanked the Bursar and the other members of the task force for their work in preparing the proposals and advised that the Resource Management Working Group and the Board will discuss the proposals later in October.

CL/04-05/009 Departmental Reviews

(i) Physiology

A report from the Provost dated 1st October 2004 on the review of the Department of Physiology had been circulated. The reviewers were impressed by the range and quality of physiology teaching in all areas, both in lectures and practicals, and identified several features of the Department's teaching programme which they considered to be particularly noteworthy. They

indicated that the methods for determining progression from MSc into PhD programmes were well established and effective. They suggested that postgraduate students should be encouraged to undertake short courses designed to enhance their personal and academic development. In relation to the Department's research programmes, the reviewers stated that overall, they were highly commendable and effective. They noted that the established programmes in cellular neuroscience led by senior staff are of international standing and programmes in related areas by recently appointed staff are also of high quality and are of national standard. The reviewers considered that the department is under-resourced in every respect for the role it undertakes. They suggested that College and Faculty funding models be made open and transparent. The reviewers also recommended that the Department should align itself more closely with other departments and they offered a number of suggestions for consideration.

The Dean of Health Sciences commended the positive findings of the reviewers and invited Council's attention to the serious resource deficiencies in the Department, as commented on by the reviewers. He also stated that the report should be considered in conjunction with the report on the review of the Department of Anatomy, which also recommended amalgamations of departments.

Council was advised of an amendment to the name of one of the Department's two postgraduate taught programmes as stated in section 2.2 of the report, the programme titles should read 'MSc in Mammalian Cell Physiology' and 'MSc in Exercise Physiology'.

Council noted and approved the following recommendations:

(a) that the Department should

- 1. In the context of College and Faculty re-organisation and while considering the reviewers' recommendations with regard to re-organisation, actively engage in discussions with a range of departments before any new configuration of Departments/ Schools is decided
- 2. Develop plans for teaching and research programmes and resourcing in the context of the overall curriculum in medical education
- (b) that the Faculty should
 - 3. Facilitate the Department in identifying and forming a new configuration with other departments that will work to the Department's and the College's best interests in teaching and research
- (c) that College should
 - 4. Support the Department, the School of Physic and its teaching hospitals in achieving international eminence
 - 5. Ensure that the discipline and the School is positioned appropriately within the new structures

(ii) Radiation Therapy

A report from the Provost dated 1st October 2004 on the review of the School of Radiation Therapy had been circulated. The reviewers indicated that the School of Radiation Therapy was providing excellent training for radiation therapists and met all the standards expected of such a school. The reviewers commented on the very high standard of final year projects and made a number of suggestions for improvement in relation to how teaching is delivered and assessed. At the time of the review, the School had no

postgraduate students but the reviewers considered that with recent new staff appointments, it should be possible to develop the postgraduate area. The reviewers noted the areas in which research is currently being carried out and indicated that the previously limited research potential of the School has expanded with the addition of new staff. In relation to facilities, the reviewers commended the School's excellent equipment and accommodation.

The Dean of Health Sciences stated that the report was very complimentary of the School and noted that it identified the importance of the School's links with the Academic Unit of Oncology. The Dean noted the reviewers' comments regarding the proposed two comprehensive cancer care centres in Dublin and he indicated that this would have profound implications for the College and its teaching hospitals. He also advised Council that discussions are to take place with St Luke's Hospital in relation to a new teaching agreement that will take into account the recommendations contained in the reviewers' report.

Council noted and approved the following recommendations:

- (a) that the School should
 - 1. Anticipate and plan for changes in radiation oncology at hospital level
 - 2. Implement the recommendations of the reviewers in relation to its teaching programme, including problem-based learning
 - 3. In the context of Faculty developments and the development of postgraduate and research activity, consider the merit of combining with related research initiatives in the Faculty
- (b) that the Faculty should
 - 4. Recognise the importance to the School of close proximity to one of the new comprehensive cancer care centres to be established in Dublin
 - 5. Support the School in developing its research performance
 - 6. Ensure that the School can fulfil the requirements of the professional accreditation process
- (c) that College should
 - 7. Ensure that the School's development complies with the College's strategy to be a research-led institution of international standing
 - 8. Ensure that the School is positioned appropriately within the new structures.
