A meeting of the University Council was held on Wednesday 10 November 2004 at 11.15 am in the Board Room.

SECTION A

CL/04-05/029 Minutes The minutes of the meeting of 13th October 2004 were approved.

CL/04-05/030 Matters Arising from the Minutes A number of matters arising from the Minutes were discussed and have been minuted under appropriate headings hereafter.

CL/04-05/031 European University Association (see Actum CL/04-05/006 (ii) of 13th October 2004)

The Senior Lecturer reported that the EUA had visited College on 14-16 October 2004 and had concluded the visit with an oral presentation of its main findings. The Review Team had been supportive of the system of self-regulation of quality assurance in Ireland. The main recommendations relating to activities of the Quality Office/Centre for Academic Practice and Student Learning were that (i) student evaluation of courses should be mandatory; (ii) the response from the Department (which is invited eighteen months following presentation of the Provost's report to Council) should be considered by the University Council; and (iii) the schedule of reviews should be extended to seven years.

The Senior Lecturer advised Board that in addition to issuing a sectoral report to the Irish Universities Quality Board (IUQB) and the HEA, the EUA would also issue a final report on each institution. Each institution will have an opportunity to comment formally on its report prior to its submission, together with the institution's comments

and those of the IUQB, to the Minister for Education and Science. On completion of this process each university will be required to publish its report on its website.

Research – Report from the Dean (see Actum CL/04-05/007 of 13th October 2004) The Vice-Provost advised Council that very significant effort had been involved in producing an Annual Overhead Investment Plan for submission to Science Foundation Ireland (SFI). The Dean had presented the proposal to a panel involving members of the SFI and others on 8th November and the outcome of that submission was not yet known.

Key Principles/Issues associated with an Academically-based Resource Allocation Model (see Actum CL/04-05/008 of 13th October 2004) The Vice-Provost reported that the paper discussed at the previous Council meeting had also been discussed by the Resource Management Working Group and by the Board. The Board had requested the Task Force to prepare a Questions and Answers paper which would be published on the Structures, Management and Systems website later in the week. Among the issues discussed by Board were the funding of student services and of the Library, how research would be weighted in the model, and the flexibility of the model in responding to fluctuations in student demand.

In response to a comment from the Vice-President of the Graduate Students' Union that the minutes had not captured all the nuances of the discussion at the previous meeting, the Senior Lecturer advised that all the issues raised had been noted in detail by the members of the Task Force and will be addressed. The Senior Lecturer confirmed that any comments received on the paper will be published on the website.

Provost's Report In the absence of the Provost, the Vice-Provost reported on the following issues:

(i) Academic Structures The Provost had sent an email to staff on 9th November 2004 which provided an update on discussions regarding academic structures. The email noted that the bottom-up consultation exercise had progressed to the extent possible and it was proposed that in the two week period before the November Board meeting, the Provost and Officers would engage more directly with the School groupings that had suggested themselves in order to help advance their thinking. A report to the November Board meeting would present an initial view of the overall structure that is emerging.

Council noted that the student representatives on Council had not received a copy of the Provost's email and the Vice-Provost undertook to have a copy circulated to student representatives on Council and Board.

In response to a question, the Senior Lecturer stated that it was the intention to circulate a report to Board for consideration at its meeting on 24th November 2004 and a copy of that report would also be circulated for consideration by Council at its meeting on 1st December 2004. It was agreed that the paper would be posted on the website following consideration by Board.

The Senior Lecturer advised that, in accordance with its decision of 7th July 2004, the Board will make firm decisions no later than its December meeting on the number and composition of Schools/Departments. Decisions in relation to (i) the election versus selection of Heads, and (ii) the number, composition and role of Faculties and on the role and methods of appointment of Deans, would also be made by Board at its December meeting.

(ii) Working Party on Administrative and Support Structures Information on the terms of reference of the Working Party on Administrative and Support Structures was available on the Structures website together with details of its membership. The Vice-Provost chaired the Working Party and she advised Council that preliminary work had begun in relation to data collection and that issues surrounding service level agreements were being investigated.

The Vice-Provost also advised Council that a task force had been established to develop a high-level information systems strategy for the College. It had also begun its work and had drafted preliminary guidelines for a new information systems strategy for the College.

Organisation for Economic Co-operation and Development (OECD) Report A memorandum from the Provost to Board dated 19th October 2004 had been circulated, together with the Conclusions and Recommendations section of the OECD report. In addition, the circulated information included a list of the Report's recommendations that referred specifically to issues that institutions themselves should consider and which did not require changes to the Statutes and/or the Private Act.

While the OECD report acknowledged the need for investment in third-level education, it noted that the system should not rely on state funding alone and it recommended that undergraduate fees be re-introduced. As there appeared to be a lack of political will to follow through on this recommendation, there was a real dilemma facing the sector. The Senior Lecturer informed Council that a sub-group of the Conference of Heads of Irish Universities (CHIU) had met the previous day to begin to develop a response to the report which would be submitted to the government and the Higher Education Authority. It was noted that the government's estimates would be published shortly and it would be important to ensure that a strong case was made for additional funding for the sector.

With regard to the relationship between the universities and the institutes of technology, the OECD report confirmed the binary system and recommended that the differentiation of mission between the universities and the institutes of technology be preserved.

The Senior Lecturer also drew Council's attention to the recommendation that the number of doctoral students in the universities should double by 2010, and that the number of international students should double in the next five years.

In the discussion, it was suggested that some of the recommendations in the report regarding PhD students could have implications for the quality of the degree. It was noted that in England, PhD students were funded for three years only and this had adversely affected completion rates. Significant additional funding would be required to support the doubling of numbers. The Dean of Graduate Studies commented that in addition to financial support, factors such as student demand and the capacity of the College to carry an increased supervisory load would have to be considered. Furthermore, while the report may have focussed on science-based areas, the College wished to increase research student numbers across all disciplines, as stated in the Strategic Plan.

The report indicated that in general, PhD awarding powers should be restricted to the university sector, and that where doctoral students were working in institutes of technology, they should always be registered for university degrees and work under a university supervisor, but with a joint supervisor in the institute. The Vice-Provost stated that if such arrangements were entered into, the quality of the PhD would be

monitored by staff in Trinity and the degree would be awarded by the University of Dublin.

Members of Council expressed some concern regarding the autonomy of the university in the context of the recommendation that there should be a National Council for Tertiary Education, Research and Innovation to be chaired by the Taoiseach, which would determine a rolling national strategic agenda for third-level education and its relation to innovation, skilled labour force and the economy. The Report also recommended that a new Tertiary Education Authority (TEA) be established, replacing the Higher Education Authority. The proposed TEA would be a single funding authority for both the universities and the institutes of technology, and institutions would agree a contract with the TEA on the basis of an institutional strategic plan. While the report recommended that multi-annual funding be put in place, it also noted that contracts with institutions be renewed annually. The Vice-Provost commented that the HEA and the government recognised the importance of establishing multi-annual funding for the universities.

It was noted that the report contained a number of recommendations in relation to governance that would be addressed by the Board.

In drawing the discussion to a close, the Vice-Provost noted that the Board would discuss the report at its next meeting.

Admissions 2004 A memorandum from the Senior Lecturer dated 3rd November 2004 had been circulated together with updated tables on CAO first preference applications (including quotas, points, and numbers registered) and on the distribution of points within undergraduate courses. The Senior Lecturer invited Council's attention to the following points

- The number of applications to the CAO in 2004 had decreased by 1.5% on the previous year
- The number of first preference applications to Trinity had increased by one percent
- There was an overall ratio of 1.9:1 eligible first preference applications to quota
- 53% of the intake had 500 points and above, a pattern consistent with previous years
- Science, Business Economic and Social Studies, and Engineering, all with a quota of in excess of 170, had maintained a strong sectoral position
- The points for Mathematics increased significantly despite an increase in the quota for Mathematics in the Two-subject Moderatorship programme
- Several courses did not fill their quota
- The policy of reserving 15% of quotas for non-traditional applicants was implemented for the first time in 2004 and 10.5% of quotas were filled with non-traditional applicants (7% in 2003).

In response to a question, the Vice-Provost advised that the Department of Computer Science had taken various actions to address the fall-off in demand for several of its undergraduate courses, including the re-structuring of programmes. In relation to Engineering, although its ratio of eligible first preference applications to quota was 1:1, the course had filled its quota and maintained its points level. Concern was expressed that there were no admissions to Jewish Studies within the Two-subject Moderatorship programme.

Council noted that entrance exhibitions were awarded to students who achieved 545 points and above. While the number of exhibitioners increased each year, some members of Council were of the view that the points level for the award should not be

increased. It was acknowledged that the monetary value of the award was low in comparison to similar awards available in other institutions.

The Senior Lecturer answered a number of questions and clarified points raised. It was noted that the Senior Lecturer's Annual Report for 2003-04 would be circulated for consideration at the next meeting and would provide more detailed information on admissions and on other aspects of the activities in the Senior Lecturer's Area.

Description of Current Provision and Policy in relation to Lifelong Learning and Options for Development A memorandum from the former Senior Lecturer dated 15th June 2004 had been circulated together with a copy of the Report. Council had given preliminary consideration to the report at its meeting on 23rd June 2004 and it had been re-circulated to allow further discussion. The Senior Lecturer invited attention to the statement in the report that the number of undergraduate and postgraduate students on courses offered in the College (other than full-time undergraduate degree programmes and postgraduate degrees by research alone) totalled 3599, representing 24% of the student population. In addition, there were 1349 students enrolled for uncertified courses. The student numbers involved and the variety of programmes available indicated that the College had a significant involvement in lifelong learning, particularly in the postgraduate area.

The Senior Lecturer stated that he hoped to make progress in developing a profile of the College's lifelong learning activities for presentation to external audiences. In addition, he would consult with the Director of the Centre for Learning Technology on whether the Centre might support lifelong learning through the further development of e-learning. It was noted that the OECD Report had recommended the development of lifelong learning opportunities and Council further noted that the promotion of lifelong learning was one of the objectives of the Bologna Process. The Senior Lecturer stated that the task force working on the Academic Resource Allocation Model will also consider how lifelong learning courses should be treated in terms of weightings and priorities.

The following were among the points raised in the discussion:

- The Education Officer of the Students' Union welcomed the reference in the report to modularised courses and he suggested that Council should give this further consideration. The Vice-Provost accepted the need for more flexible learning pathways but indicated that it was unlikely to be addressed in the current year given the current discussions on re-structuring
- Consideration should be given to developing the College's involvement with the National Distance Education Centre which offers a Bachelor in Arts programme through distance education, in conjunction with Trinity and other Irish Universities
- Students on part-time courses did not always have the same access to grants as full-time students and it was suggested that this matter should be raised with CHIU
- The Senior Tutor stated that evening students were somewhat disadvantaged in that (i) they were not assigned tutors and (ii) were often not able to access support services such as Student Health or Student Counselling as such services were not open in the evening
- If the College wished to develop lifelong learning activities, incentives should be offered to staff wishing to participate.

Arising from this discussion, the Dean of Graduate Studies advised that in conjunction with the Bologna Desk in the Senior Lecturer's Area, he was involved in a pilot scheme to produce the Diploma Supplement in 2005 for a number of postgraduate courses. Preparatory work involved the identification of elements within courses and the allocation of credits to the components of a course. It was noted that a review of credits assigned to all undergraduate programmes was in progress.

Council noted that the report should be amended to reflect the fact that part-time evening degree programmes are offered in the Faculties of Engineering and Systems Sciences, Health Sciences, and Business Economic and Social Studies.

On behalf of Council, the Vice-Provost thanked the Senior Lecturer for presenting the report.

- (ii) Students' National 10K Walk Council members were invited to participate in the Students' National 10K Walk which would take place on 18th November 2004 starting at 1pm from Front Square. The aim is to raise funds for the children of post-Chernobyl Belarus, which was affected by the nuclear disaster in 1986.
