A meeting of the University Council was held on Wednesday 15 February 2006 at 11.15 am in the Board Room.

The Vice Provost welcomed Dr John Nash who made the statutory declaration. She also welcomed Patricia Callaghan, Acting Academic Secretary.

SECTION A

- CL/05-06/078 Minutes** The minutes of the meetings of 7th December 2005 and of the 13th January 2006 were approved subject to the following amendment to Actum CL/05-06/062 of 7 December 2005. The final sentence in paragraph 2 should read: "He requested that the guidelines being prepared by the Senior Lecturer should be in consultation with the Students' Union officers."
- CL/05-06/079 Matters Arising from the Minutes** A number of matters arising from the Minutes were discussed and have been minuted under appropriate headings hereafter.
- CL/05-06/080 Senior Lecturer's Annual Report 2004-2005 (including Admissions Data for 2005) (see Actum CL/05-06/060 of 7 December 2005)** The Senior Lecturer referred the meeting to Actum CL/05-06/060 and noted that a proposal on the distribution of CAO places within the 15% quota reserved for non-traditional students would be brought for discussion to a future meeting of the Undergraduate Teaching and Learning Committee.
- CL/05-06/081 Heads of School Committee (see Actum CL/05-06/062 of 7 December 2005)** The Senior Lecturer referred the meeting to Actum CL/05-06/062 on the recommendation by Council that a covering memorandum should accompany the Heads' Committee draft minutes specifying the items for which approval of Council was being sought. He

advised that Council is required to note the minutes of a principal committee in their entirety and approve recommendations as appropriate: in light of this, the suggested arrangement should not apply. He added that Council's attention would be drawn in the normal way to items of significant importance for discussion.

In response to a question from the Vice-President of the Graduate Students' Union, the Senior Lecturer confirmed that the recommendations arising from the minutes of the Heads' Committee were approved when considered at Council. Some concern was expressed that the minutes of the Graduate Studies Committee were not circulated to Council for approval especially in light of the Deans' responsibility as set out in Chapter XIII of the Statutes. The Senior Lecturer remarked that Council had delegated responsibility to the Heads' Committee, and that the Statutes would have to be revised to reflect the new academic structures.

In response to a question, the Secretary confirmed that the higher degrees awarded in December 2005 were approved by Board. He also confirmed that under the terms of the Universities Act 1997, all Council decisions were subject to Board approval.

CL/05-06/082 Strategic Plan The Vice Provost informed the meeting of progress on the strategic planning process. The first part of the Schools' Strategic Plans have now been received from all Schools and Vice-Deaneries and three review groups have been established to evaluate the plans in respect of (i) undergraduate education, chaired by the Senior Lecturer, (ii) graduate studies, chaired by the Dean of Graduate Studies, and (iii) research, chaired by the Dean of Research. Schools will be invited to complete the second part of their Schools' Strategic Plans on staffing, infrastructure and finances. Staffing and financial templates have been prepared to assist in the preparation of this phase of planning and workshops are scheduled for the week beginning the 20th February. The Resource Management Committee and the Personnel and Appointments Committee will evaluate the resource planning phase of Schools' Strategic Plans.

The Vice-Provost reported that the College's Strategic Plan 2003-08 was currently being revised. A draft of the College's Strategic Plan will be available for consultation in Trinity Term and presented to Council and Board in July 2006. A call for bids to the Strategic Innovation Fund is expected to be announced shortly and the Vice-Provost noted that the College's Strategic Plan would be essential in preparing a submission to this fund.

In response to a question, the Vice-Provost confirmed that the College's revised Strategic Plan would be brought to Council for discussion.

CL/05-06/083 Statutes – Chapter XIII : The University Council The Registrar introduced this item. He circulated a document which was considered at the Board meeting of the 6th July 2005 outlining four options for Council composition in 2006-07. Board had subsequently approved Option B and agreed in principle to the modification of the University Council. Option B recommended the Council's membership as follows: six College Officers, *ex officio* (Provost, Vice-Provost, Senior Lecturer, Registrar, Senior Tutor, Dean of Graduate Studies); five Deans, *ex officio*; five junior faculty representatives; ten representatives of Heads of School / Vice-Deans; two representatives of the Senate; two co-opted members; four student representatives (including Education Officer of Students' union and Vice-President of Graduate Studies' Union, *ex officio*); five student observers; three College Officers in attendance - The Secretary, the Librarian and the Academic Secretary.

The Registrar informed the meeting that he had delayed proposing changes to Chapter XIII of the Statutes of the University Council until a decision had been taken on

administrative reform, especially as this might relate to the role and responsibilities of academic officers. A working party of Board members was set up to assist the Registrar in the preparation of a draft ordinance which, if accepted, would be put to Fellows for their assent. He advised that there were several issues that require consideration and noted that in the coming weeks he would seek the views of Council members on five main topics: (i) the unintended consequences of the merger of the Arts Faculties for the composition of Council; (ii) whether the request from Scholars to be represented on Council be accommodated, and if so, how?; (iii) whether the Dean of Research should be a member of Council; (iv) the statutory obligation for Faculty Deans to make periodic reports to Council on general strategic issues; (v) the possibility of replacing the junior faculty representatives on Council with a general academic constituency.

In the discussion that followed it was suggested that the debate on the composition of Council should be reviewed further. It was felt that Option B might not allow for adequate representation of senior academic members. In response to a question, the Registrar commented that the Heads of School Committee should nominate the ten Heads of School members on Council. The meeting enquired about the utility of having two places reserved for co-opted members given that these have been vacant for some years now. Following a lengthy discussion on the composition of Council 2006-07, the Registrar agreed to circulate electronically the issues identified above to Council members. It was agreed that principles approved by Board were acceptable, subject to further consideration of these issues. The Secretary noted the urgency and importance of updating the Statutes to reflect the new academic structures.

CL/05-06/084 Modularisation and Trimesterisation The Senior Lecturer introduced the proposal on modularisation and trimesterisation, a copy of which had been circulated with papers for the meeting. He informed the meeting that the proposal had been discussed at the Heads' Committee of the 31st January 2006. The purpose of the discussion document was to establish whether Heads were supportive of College exploring further the case for, and issues concerning the introduction of modularisation and trimesterisation. The Heads agreed that a working group should be established, with five or six members of the academic staff, student representatives, and administrative support provided by the Senior Lecturer's Office. A number of external people may also be invited to participate. It was further agreed that the working group will conduct a detailed analysis of the issues involved, consult widely throughout College, identify options for consideration, and recommend the most appropriate model for Trinity College.

The Senior Lecturer invited Council to note the recommendation of Heads to establish a working group on modularisation and trimesterisation. While it was proposed that a final recommendation be brought to Council before the end of the academic year, it was acknowledged that this timescale was fairly tight and that it may be necessary for it to be extended.

Central to the discussion that followed was the role of the Council in initiating and directing the debate on policy issues of strategic importance to the university. It was felt by some that the debate on modularisation had already begun at Heads and clarification on governance procedures was sought in respect of the role of the Heads' Committee vis-à-vis Council. The Senior Lecturer clarified that Council had delegated authority to the Heads' Committee and one of the terms of reference of the Heads' Committee is 'to initiate discussion of new policy on academic matters including undergraduate programmes, postgraduate taught programmes and postgraduate research programmes and to make recommendations to University Council as appropriate.' The proposal discussed at Heads and the options proposed in the paper were in the context of framing general issues on the topic of modularisation and intended as reference points for discussion. In a response to a number of specific questions of detail, the Senior Lecturer advised that the paper set out some issues

pertinent to the debate on modularisation, and that he was not advocating any particular model. He further advised that the detailed debate would begin with College-wide consultation in the preparation of a firm proposal on the issue.

It was suggested that the proposed working group should be a sub-committee of Council and that Council should approve its terms of reference and membership. It was further suggested that the composition of the working group should be as representative as possible of the College community. Following a lengthy discussion on the membership, terms of reference and reporting lines of a proposed working group, the Senior Lecturer confirmed that Council would have the opportunity to fully discuss this issue. Reminding the meeting that Council had delegated authority to the Heads' Committee, the Vice-Provost advised that it was counter-productive to now attempt to revisit the procedural process already approved by Council and Board. Council noted the establishment of a working group on modularisation and trimesterisation.

The Senior Lecturer undertook to advise Council at its next meeting on the terms of reference and membership of the working group.

CL/05-06/085 **Chairs** Council approved the appointment of the External Assessors for the Regius Chair of Greek (1761) and for the Chair of Latin (1870) as proposed by the Secretary.

CL/05-06/086 **Heads of School Committee** The Senior Lecturer introduced the draft minutes of the Heads' Committee meetings held on the 10th January and the 31st January 2006, copies of which had been circulated. He invited attention to the minute of the 10th January 2006 on the ARAM Task Force, noting that the Task Force will be attending the next meeting of the Heads' Committee on 28th February 2006. The 2004-05 ARAM data had now been circulated to the Heads of School / Vice-Deanery. In response to a question, the Senior Lecturer confirmed that Board had been briefed on the ARAM.

The Senior Lecturer drew the meeting's attention to the minute of the 31st January 2006 on the 30% fee increase for M.Litt., M.Sc. (by research) and PhD programmes and advised that this proposal had been approved by the Finance Committee at its meeting of the 8th February 2006. The Vice-President of the Graduate Students' Union noted the Graduate Students' Union reservations about this increase, and argued that the 30% increase would adversely affect graduate recruitment to some postgraduate programmes. The Dean of Graduate Studies confirmed that the increase did not apply to non-EU students currently on the register, however, the standard increase of 9% would apply. The 30% increase was effective from the 2006-07 academic-year. The Dean argued that the 30% increase would offer a greater incentive for Schools to recruit non-EU students. The Registrar commented that the non-EU fee for undergraduate programmes has increased by only 5%.

Speaking to the minute of 31st January 2006 on the reporting lines of the Deans' Committee, the Dean of the Faculty of Science expressed concern about the ability of Deans to act as 'honest brokers' since Faculty Offices depend financially on Schools / Vice-Deaneries. He argued that Faculty Offices cannot operate in isolation and that the current structure does not facilitate good relations. The Senior Lecturer advised that the reporting lines of the Deans' Committee would be reviewed when statutory changes for the composition of Council membership have been approved.

In response to a question on the minute of the 31st January 2006 on performance management, the Vice-Provost commented that performance management is a condition of the National Pay Agreement, Sustaining Progress, and that the University did not intend to use performance management as a staff appraisal tool. The Senior

Lecturer confirmed that his office was not responsible for overseeing the implementation of performance management in Schools.

The Senior Lecturer in response to questions on the Heads' Committee minutes, explained that the Heads' Committee discussed the item on Socrates and requested observer status on the Finance Committee because Heads of School / Vice-Deanery have responsibility for the School finances and it is within the terms of reference of the Heads' Committee 'to consider all matters of academic policy involving finance, resources and staffing, and to make recommendations to the relevant committees.'

CL/05-06/087 Nominations for Appointment The nominations were approved (see Appendix 1 and 2 to this minute) subject to the withdrawal for technical reasons of a named candidate from the list dated 15th February, 2006.

CL/05-06/088 Award of Ordinary Degree of BA Under Other Business the Council approved the recommendation of the Nutrition and Dietetics Court of Examiners that a named student be awarded the Ordinary B.A. Degree in recognition of successful completion of the Junior Sophister year, as the student has been unsuccessful in Final Examinations due to failure to complete successfully the clinical components.

The Senior Lecturer noted that this provision will be included in the Calendar 2006-07, and further noted that the award of an Ordinary B.A. degree would not confer a professional qualification on the student.

SECTION B

CL/05-06/089 Information Policy Committee Draft minutes of the meeting of 14th December 2005 had been circulated. The Librarian confirmed, in response to a question, that a proposal on the Institutional Repository would be brought to the Information Policy Committee in due course.

Draft minutes of the meeting of 16th January 2006 had been circulated and the Vice-Provost invited attention to minute 24 on eStrategy. She advised the meeting that the Bursar is now the College Officer responsible for eStrategy and that he has also taken over as Chair of the Information Policy Committee.

The Council noted the minutes of the Information Policy Committee of the 14th December 2005 and the 16th January 2006.

CL/05-06/090 Personnel and Appointments Committee Draft minutes of meetings of 14th December 2005, of the 11th January 2006 together with the Roles and Responsibilities of Head of School/Vice-Dean in relation to Staff Matters, and of the 25 January 2006, together with a proposal on Service Days.

Addressing minute PAC 2005-06/118 on service days, Mr Benson expressed disappointment with the 27 day cap eligibility. Only staff members with a leave entitlement of less than 27 days are eligible for the additional service day leave and he argued that this cap discriminated against middle-ranking staff. The Vice-Provost confirmed that the Partnership Committee had agreed the arrangement on service days.

It was noted that the minutes of the Personnel and Appointments Committee meeting of 30 November 2005 had not been circulated to Council. It was agreed to circulate these with the papers for the next meeting of Council.

- (i) Professor Begley sought clarification on title of Vice-Provost for Medical Affairs attached to the new Head of School of Medicine, Professor Kelleher. Dr Kelly and Professor Claffey also expressed their concern that there had been no discussion with the other Heads of School within the Faculty of Health Sciences Faculty. Dr Kelly suggested that the matter might be deferred to allow for further discussion. The Secretary advised that since Board had already approved this appointment, and confirmed that the title was unique to the current holder, the matter was brought to Council for information. He added that in the context of the enormous changes facing medical education in Ireland, the Board approved that the Head of School should represent the Provost when negotiating these changes with hospital stakeholders and the title Vice-Provost for Medical Affairs would facilitate this. The relation with the Dean of the Faculty would be similar to that of all other Heads of School in the Faculty.
