## LIPC/14-15/3 The Library Strategy 2014-2019

- 3.1 The Librarian presented the key points of the Library Strategy to the committee; she confirmed the role is to define and attain the next level of a major university research library is in the early 21st Century. She highlighted the current context; we are operating in a time of great disruption in higher education and transformation in library services.
- 3.2 The Library Strategy is aligned to the College Strategic plan, and other critical initiatives, for example The Visitor Experience Master plan.
- 3.4 The strategy has 10 elements and runs to 10 pages. These include the context, a library "manifesto", next five years, the five strategic priorities, the approach and the dependencies and interdependencies.
- **3.5** Following the Librarian's presentation members of the committee provided feedback on several points in the strategy, including terminology, tone and specific content.

- 3.5 During the conversation it was noted that there is a college wide digital strategy committee being formed, possibly by the director of Communications.
