<b>Section A – Items for Discussion and Approval</b>	
<b>A.1</b>	<p><b>Minutes</b> Minutes from the meeting of January 18<sup>th</sup> were circulated in advance. An amendment was noted for item B.2 which was incorporated and minutes were then approved.</p>

<b>Section B - Items for Discussion Only</b>	
<b>B.1</b>	<p><b>RS/21-22/12 Virtual Trinity Library</b> Helen Shenton, Librarian and College Archivist</p> <p>Helen Shenton presented an overview of the Virtual Trinity Library project to the committee. The project will unlock Trinity’s extensive unique and distinct collections, making them accessible and visible through advanced technology, and create a new Irish research entity and a digital library for the world. It was noted that the project will facilitate international collaboration, encourage philanthropic donations of content and collections, contribute to a new universal digital entity, encourage technological advances, and create new positions.</p> <p>The committee noted that this was a wonderful project. It was also noted that there were currently significant issues in Trinity around a sustainable digital base for research projects. It was noted that building digital preservation, data management, and presentation should be factored into projects from the outset but this does not happen on a consistent basis due to funding constraints. Members of the committee noted that this was a common problem at a national level and that the committee could advocate for a sustainable solution at a sectoral level.</p> <p>It was noted that different types of material needed to be preserved; some material should be available and open, but other data needed to be preserved and closed. It was noted that there are different approaches to long-term preservation and that good models do exist elsewhere. The committee was reminded that Research IT works with PIs where possible to pool funding so that researchers can have access to the infrastructures they need. It was noted that greater awareness was needed around the importance of building digital aspects into grant applications from the beginning. The committee also noted that digital preservation was a core research infrastructure that should be appropriately resourced.</p>
<b>B.2</b>	<p><b>Update from Dean of Research</b> Dean of Research</p> <p><b>RS/21-22/13</b> The DOR noted that government had proposed the establishment of a public-private initiative to create 1,000 PhD studentships over the next 10 years. It was noted that the timeline to have this scheme up and running was extremely tight and that while Trinity generally welcomed schemes of this kind, clarity was still needed around timelines, retention, and administration.</p> <p><b>RS/18-19/19</b> It was noted that funding for NORF had been announced. DFHERIS and HEA allocated €1.725million to the Digital Repository of Ireland to work closely with NORF to implement an open research ecosystem. It was noted that the National Action Plan was still under review, and the consultation phase had moved again. Draft was</p>

	<p>expected to be shared at the end of February, consultation throughout March, with a view to publication in April. It was noted that the funding was for this calendar year but could be carried over if unspent.</p> <p><b>RS/21-22/3</b> Following on from an audit of state aid by the European Court of Auditors SFI had wanted to conduct an audit of specific projects. The IUA and universities rejected this approach and had instead agreed to collaborate with SFI in a pilot project about reviewing SFI's checklist for state aid issues. DOR advised the committee that this issue was resolved for the moment until the pilot is concluded.</p> <p>It was noted that DFHERIS was running two national consultations: on a National Research Classification System, and on the International Education, Research and Innovation Strategy. Members of the committee noted concern at how research had apparently been included in the international strategy consultation as an afterthought.</p> <p><b>RS/19-20/5</b> DOR advised the committee that under EU and university legislation the governance of Clinical Trials must be overseen by a Head of Clinical Sponsorship Oversight. Committee was advised that this position was currently vacant and that the Office of the Dean of Research had commenced recruitment so that grant applications can proceed. It was also noted that a Quality and Regulatory Affairs Manager would be appointed. In response to questions from the committee the DOR advised that reporting lines had yet to be confirmed for the QRAMS post but that the HCSO would report to the Dean of Research.</p> <p>The committee was advised that the Royal Irish Academy had opened a call for memberships of its multidisciplinary committees.</p> <p><b>RS/19-20/3</b> DOR and ADOR Immo Warntjes met with Mary Leahy in relation to postdoc teaching issue. HR committee was generally positive about the addition of a clause to contracts. DOR and ADOR Warntjes would provide a short guidance document to be circulated to schools. It was noted that a more longterm approach would be helpful for postdocs but the committee was generally pleased to see this issue progressed. DOR noted that the committee would be advised when it was ok to proceed with the new arrangement.
