### About Us:

This Research Ethics Conversation Series is jointly convened by Trinity College Dublin and the University of Galway. We seek to bring together an interdisciplinary community of inquiry to engage in exploratory conversations about new and/or difficult, thorny issues in research ethics, as identified by researchers working in the field as well as those engaged in research ethics oversight and other relevant areas of higher education practice. We believe in creating this communal space for those interested in the broad field of research ethics across multiple disciplines, as a key issue we see is the lack of a safe space for dialogue between researchers and ethics committees on emerging ethics topics, where there is yet to be a well-founded consensus, and where diverse stakeholders with different perspectives and traditions need to have their voices heard and listened to. We strongly believe that research ethics should be open, inclusive, and pluralistic, and to be broadly discussed and deliberated amongst practitioners and policymakers. We are interested in facilitating a space for discourse and reflection among those keen to push forward the progress of research ethics through both critique and consensus.

### Format:

Based on the experiences gained from our very successful inaugural series last year, we will continue with a monthly programme of Conversations, starting in late March, with a break over the summer period. There is a total of 8 Conversations each calendar year (March to June, September to December), taking place in either the third or fourth week of the month, usually on a Thursday. The session is scheduled from 3pm to 4:30pm, allowing space for a proper conversation to develop.

While the lead speaker may present a topic for about 45 minutes (the range could be from 30 minutes to an hour), the rest of the time in this 1.5 hour session will be devoted to conversation amongst the group on the topic. The session will be chaired by either of the series co-convenors (Mandy or Su). Slides (where relevant) by the lead speakers will be circulated, with the authors' agreement, to the email list members for further reflection/action.

## 2025 Lead Speakers' Biographies (in Alphabetical Order):

### **Dr. Ghaiath MA Hussein**

Assistant Professor of Medical Ethics, School of Medicine, Trinity College Dublin

Dr. Ghaiath Hussein is an Assistant Professor of Medical Ethics and Law at Trinity College Dublin, University of Dublin, Ireland. A medical doctor, bioethicist, and public health specialist. He holds an MBBS from Sudan, an M.Sc. in Bioethics from the University of Toronto, and a Ph.D. in Bioethics from the University of Birmingham.

His career encompasses health research, health policy, and field epidemiology, with a focus on humanitarian settings. Dr. Hussein specializes in bioethics, with focus on research ethics, public health ethics, and humanitarian ethics. Since 2010, he has taught bioethics to undergraduate and postgraduate students, residents, healthcare providers, and public health practitioners. He also engages in ethics consultations in developing countries, collaborating with organizations like the WHO, UNESCO, and EMPHNET.

Dr. Hussein has published numerous articles in international journals, and authored chapters in national and international books and training manuals on bioethical issues related to clinical practice, health research, humanitarian settings, and global health. His recent research examines Research Ethics in complex humanitarian emergencies and north-south global ethics dialogue. Currently, he chairs the School of Medicine Research Ethics Committee and is a member of the Ethics Review Board of Médecins Sans Frontières (MSF - ERB).

### **Dr. Outi Kähäri**

Dr. Outi Kähäri is a postdoctoral researcher in the research unit for history, culture and communications at the University of Oulu, Finland. She holds a doctoral degree in sociology (University of Turku, 2017) with a specialization in migration, integration, work life studies and trust research. Her recent studies have concentrated on intergenerational relationships and (post)memories in transnational Ingrian families whose pasts include persecution and forced migration. She is specifically interested in questions of retrospective justice and memory activism in the intersection of history and sociology. Currently, Kähäri works in the Mobile Futures project exploring how young adults make everyday racism visible and tackle it, by using the methods of digital ethnography. Her field of expertise includes qualitative methods, research on institutional and social trust and interaction, sociological memory studies and minority history.

Mandy Lee is an Assistant Professor at the Centre for Health Policy and Management, School of Medicine, Trinity College Dublin. A sociologist of health and illness, her research interests include narrative medicine, trauma studies and research ethics. She served as programme coordinator for the M.Sc. Health Services Management from 2004 to 2019, and led the Research Methods and Research Ethics module over the same period. Representing her department, she served on the TCD Faculty of Health Sciences Ethics Committee from 2005 to 2009. In 2009, she helped establish the Health Policy and Management/Centre for Global Health (HPM-CGH) Research Ethics Committee, a committee that reviews both low-risk and high-risk applications from two academic units at Trinity. She co-authored the original protocols and guidelines for the HPM-CGH REC, and led efforts to ensure GDPR compliance of REC protocols in 2019. She served as deputy Chair of the HPM-CGH REC in 2021 and 2022, and retains an advisor role to the HPM-CGH REC at present. Since 2024, Mandy is a TCD co-representative on Medical and Health Humanities Working Group of the Irish Humanities Alliance (IHA), and is also a member of the advisory board on the Trinity Inclusive Curriculum since 2022. She has published on research methods and research ethics, and provided research ethics training to national agencies. She is currently pursuing a part-time PhD at the TCD Department of Sociology, focused on exploring trauma and resilience of the Hong Kong pro-democracy movement.

Dr David O'Brien is based at the Centre for International Studies and Development, Jagiellonian University in Kraków, Poland. His research project entitled 'Narrating the 'new silk road': Chinese 'huayuquan' (discourse power) in OBOR/BRI externally-directed propaganda' has received a grant of 1.2 million zloty from the prestigious programme POLONEZ BIS-2 of the Polish National Science Centre (Narodowe Centrum Nauki). He graduated with a PhD in Asian Studies from the National University of Ireland (Cork) in 2013 with a thesis entitled People and Place in the New Frontier: An Examination of the Construction of Han and Uyghur Ethnic Identities in China's Xinjiang Uyghur Autonomous Region. He was formerly at Ruhr University Bochum in Germany (2019-2023) and before that at the Chinese campus of Nottingham University (2013-2019). His work explores ethnic identity and ethnic policy in the People's Republic of China and Taiwan. His research has appeared in China Quarterly, International Politics, Journal of Current Chinese Affairs, Asian Ethnicity, among others. He is co-author with Melissa Shani Brown of People, Place, Race, and Nation in Xinjiang, China: Territories of Identity. Palgrave Macmillan, 2022. He is also the co-founder and co-director of the Irish Uyghur Cultural Association.

Dr. Pilar Luz Rodrigues is a Lecturer and Postdoctoral Researcher in the School of Political Science and Sociology of the University of Galway. As a Postdoctoral Researcher, Dr. Rodrigues is working in the Centre for Global Women's Studies on the Higher Education Authority (HEA) funded study "Intersectional Discrimination in Irish Higher Education: An Index of Intersectional Discrimination (IID) Measuring Student's Experiences of Discrimination at University of Galway". In addition to this work, Dr. Rodrigues is also leading a project at the South East Technological University (SETU) funded by the SETU EDI Fund titled "Understanding Race Equality in the South East". Previously, she worked as Postdoctoral Researcher at the School of Languages, Literatures, and Cultures, of the University of Galway, on the Irish Research Council funded project "Rural Villages, Migration and Intercultural Communication". Dr. Rodrigues concluded her PhD in Sociology in 2023, with her thesis titled "Mitigating the Effects of Precarity: Brazilian Migrant Workers and Place-Making in Rural Ireland". Her research involved 18 months of fieldwork with Brazilian migrants in rural Ireland, particularly in Gort, Ireland's Little Brazil. She previously worked as a Junior Research Consultant at the International Organization for Migration (IOM UN Migration) in their headquarters in Geneva, and as a Research and Project Assistant at the Irish Council for International Students (ICOS). She also worked as a Research Assistant at SETU on social and health related projects, including a study funded by the Irish Cancer Society. Dr. Rodrigues is a member and current co-convenor of the Sociological Association of Ireland (SAI) Race & Ethnicity Study Group.

Dr. Gerlov van Engelenhoven Med is an assistant professor at Leiden University Centre for the Arts in Society (LUCAS), teaching courses on postcolonial memory and heritage, law & culture, and cultural interaction. His most recent book is titled Postcolonial Memory in the Netherlands: Meaningful Voices, Meaningful Silences. It was published open access by Amsterdam University Press in 2023.
