Rationale and Aims

Developmental psychology is the scientific study of age-related change and consistency across the spectrum of human growth. This module aims to build upon the knowledge base students received during their Freshman years and provide a stimulating context in which to introduce them to a number of important issues that are debated in the field. Some of these issues are longstanding, some more current. The focus will be on presenting the key elements of each perspective under scrutiny and then inviting students to critically review, examine and evaluate the available information.
